THE CORPORATION OF THE TOWNSHIP OF WHITE RIVER BURNING PERMIT

RULES AND REGULATIONS

This Burning Permit authorizes the above-noted individual to set a fire in the open air within the Municipality of White River providing that Municipal and Provincial Regulations are respected.

1) No open air fires in the Municipality of White River will be set without an approved Burning Permit from April 1st to October 31st in each calendar year.

2) Any fire set in the open air shall be contained in a Fire Proof container measuring a maximum diameter of twenty-four inches, a minimum height of twelve inches and a maximum height of forty-eight inches.

3) Such fire shall be attended by a responsible competent person or persons until it has been extinguished and shall be a minimum distance of fifteen (15) feet away from any dwelling or structure.

4) Grass and leaf burning is permitted but only if Burning Permit has been obtained.

5) That the fire is ignited two hours before sunset or later and is extinguished two hours after sunrise or earlier.

6) That the burning shall not be carried out during extreme dry or windy conditions. Burning shall not be carried out of there is a Ministry of Natural Resources or Municipal fire ban in effect.

7) That the person or persons have adequate tools and water to contain the fire.

8) Any fire set at the Municipal Waste Management Site shall be a maximum of twenty-five feet away from the brush line. Fire can be larger if Municipal Fire Department is on site.

9) The Ministry of Environment, the Ministry of Natural Resources and the Municipal Fire Department should be notified. Only the material that the Ministry of Environment approves shall be burned.

10) The Fire Code and the Ministry of Natural Resources regulations supersede this by-law.

I have read and understand all of the Rules and Regulations as set out by The Corporation of the Township of White River and the Province of Ontario and will adhere to them.
